GFWC New England Region Proposed Standing Rules Amendments.

Article IV. Officers. 2. currently reads:

Proposed amendment to strike the current ARTICLE 4. Officers. 2. and insert the following to read:

ARTICLE IV. Officers. 2.

In the event Vermont wishes to field a candidate in the future, that candidate will be placed for nomination as Treasurer and the rotation shall be reconfigured.

Rationale: Vermont was unable to field a candidate and therefore the configuration was necessary.

GFWC New England Region Proposed Standing Rules Amendments, Continued:

ARTICLE IV. OFFICERS. 3.b. currently reads:

First have served as a State President, if no candidate is available, then second would be Past State Director of Junior Clubs and third would be a Past State Officer. If there are no candidates from that State, then a candidate from one of the other states, not represented, may be considered following Article IV Section 9. Vacancies.

Proposed amendment to insert the word "shall" after the word "First": strike "may" and insert "shall" after the word "represented" and strike the words "following Article IV, Section 9. Vacancies" at the end.

If adopted will read:

3b. First shall have served as a State President. If no candidate is available, then second would be a Past State Director of Junior Clubs and third would be a Past State Officer. If there are no candidates from that State, then a candidate from one of the other states, not represented, shall be considered.

ARTICLE IV. Officers. 4. currently reads:

No state shall have more than one officer serving at the same time.
Proposed amendment to strike Article IV. Officers. 4.

Rationale: Due to a State not being able to field a candidate, it may not be possible to avoid having two officers from the same State serving on the Board.

ARTICLE IV. Officers. 5. currently reads:

No officer shall serve more than one term in the same office.
Proposed amendment to strike Article IV. Officers. 5. and insert the following to read:

ARTICLE IV. Officers.

5. No person shall be eligible to serve two consecutive terms in the same office.

Rationale: Clarification. Some States may allow candidates to hold the same office more than once.

Paragraphs in ARTICLE IV. shall be renumbered.

GFWC New England Region Proposed Standing Rules Amendments, Continued:

ARTICLE VI. Duties of Officers. 2.f. currently reads:

f. At the close of the annual meeting in the odd-numbered year she shall assume the title of President-elect for the remainder of the term.

Proposed amendment to ARTICLE VI. Duties of Officers. 2.f.
strike the word "annual" and insert the word "semi-annual." If adopted to read:

f. At the close of the semi-annual meeting in the odd-numbered year, she shall assume the title of President-elect for the remainder of the term.

Rationale: To conform to current practice.

ARTICLE X. FINANCES. 7. currently reads:

The hostess state federation shall be reimbursed the sum of nine hundred dollars (\$900) by the GFWC New England Region Treasurer.

Proposed amendment to Article X. Finances 7. strike the words "nine hundred dollars (\$900)" and insert the words "one thousand dollars (\$1000): If adopted to read as follows

7. The hostess State Federation shall be reimbursed the sum of one thousand dollars (\$1000) by the GFWC New England Treasurer.

Rationale: To conform to the current budgeted amount.
